

<b>OPEN JAW</b>	OPEN JAW PERMITTED AT TURNAROUND POINT ONLY. IN ALL CASES HIGHER FARE TO BE CHARGED.
<b>CODESHARE</b>	CODESHARED FLIGHTS NOT PERMITTED.

<b>CHANGES</b>	CHANGES PERMITTED PRIOR TO TICKETING AT NO CHARGE. ONCE TICKETED NO CHANGES ARE PERMITTED. CHANGES REQUIRING TICKET REISSUE PERMITTED AT AUD22 ADMIN FEE.
<b>CANX/REFUNDS</b>	NO REFUND ONCE TRAVEL HAS COMMENCED. NO REFUNDS OR EXTENSIONS APPLY TO EXPIRED TICKETS. REISSUE OF LOST TICKET REQUIRES A FORM OF INDEMNITY PLUS A POLICE REPORT
